ACCEPTING BUSINESS OR PERSONAL CHECK PAYMENTS

VIRGINIA OR NORTH CAROLINA PERSONAL OR BUSINESS CHECK THAT IS NOT BANK CERTIFIED:

DRIVER LICENCE NUMBER OR VA ISSUED ID NUMBER MUST BE WRITTEN ON THE FRONT OF THE CHECK

VA or NC DL/ID # Written on the front of the check and NAME must match.

Name and Address must match the ID—if the address does not match, the new address needs to be written on the check.

NO PO BOX—The physical address must go on the front of the check

A current phone number must be written on the front of the check. NO COUNTER/STARTER CHECKS SHOULD BE ACCEPTED

If it is a Virginia Business Check, the name of the person presenting and signing for the payment must show their ID and their name, ID # and all the above information must be written on the front of the check beside the printed business information.

OUT OF STATE PERSONAL OR BUSINESS CHECK THAT IS NOT BANK CERTIFIED:

VALID DRIVER LICENCE NUMBER OR STATE ISSUED ID NUMBER MUST BE WRITTEN ON THE FRONT OF THE CHECK

DL/ID # Written on the front of the check and NAME must match.

Name and Address must match the ID—if the address does not match, the new address needs to be written on the check.

NO PO BOX—The physical address must go on the front of the check

A current phone number must be written on the front of the check. NO COUNTER/STARTER CHECKS

If it is an Out of State Business Check, the name of the person presenting and signing for the payment must show their ID and their name, ID# and all the above information must be written on the front of the check beside the printed business information.

PLEASE BE ADVISED: *IF A TICKET IS NOT MARKED FOR DELIVERY AND IF MERCHANDISE IS BEING TAKEN INTO POSSESSION BY A CUSTOMER THE DAY THAT A CHECK IS PRESENTED FOR PAYMENT OR IF THE MERCHANDISE IS MARKED FOR PICKUP OR CASH AND CARRY AND NOT BEING DELIVERED---THE BUSINESS OR PERSONAL CHECK CAN ONLY BE ACCEPTED IF THE CUSTOMER IS A VIRGINIA OR NORTH CAROLINA RESIDENT WITH A VIRGINIA OR NORTH CAROLINA CURRENT FORM OF IDENTIFICATION AND A BANK THAT IS LOCATED IN THE STATE OF VIRGINIA OR NORTH CAROLINA WITH THE CUSTOMER'S CURRENT ADDRESS ON THE CHECKING ACCOUNT. CHECKS PAYMENTS FROM ANY OTHER STATE WILL NOT BE ACCEPTED AS PAYMENT BY GFF INC WITHOUT PRIOR AUTHOIZATION FROM AN OWNER, COO, OR STORE MANAGER FOR PURCHASES MORE THAN \$250 THAT ARE LEAVING THE STORE WITH THE CUSTOMER OR BEING PICKED UP WITHIN A SHORT TIME OF THE PURCHASE DATE.**
